### **FROM WASHINGTON/BALTIMORE/DELAWARE**

Take 95 North to 295 North to the Delaware Memorial Bridge. Take Delaware Memorial Bridge to the New Jersey Turnpike North. Take Turnpike to Exit 2. Take 322 East (Towards Glassboro) for about 12 miles. Get on Route 55 North and take for about 5 miles. Get off at Exit 56A (Hurffville/Glassboro). Go to the first traffic light and make a right. You will go through one traffic light at County House Road. The next street on your left is Enterprise Court. Make a left onto Enterprise Court and proceed to the end of the cul de sac.

### **FROM CHESTER & DELAWARE COUNTIES, PENNSYLVANIA**

Take Commodore Barry Bridge to New Jersey. Get on Route 322 East. Follow Directions above.

### **FROM WALT WHITMAN BRIDGE**

Take Route 42 South and take Exit for Rt. 55 South. Get off Rt. 55 at Exit 56A (Hurffville/Glassboro). Go to the first traffic light and make a right. You will go through one traffic light at County House Road. The next street on your left is Enterprise Court. Make a left onto Enterprise Court and proceed to the end of the cul de sac.

### **FROM BEN FRANKLIN BRIDGE**

Take 676 to Route 42 South. Follow directions above

### **FROM TACONY PALMYRA BRIDGE**

Take 73 South to 295 South. Take 295 South to Route 42 South and follow directions above.

### **FROM BETSY ROSS BRIDGE**

Take Route 90 to Route 73 South and follow directions above.

### **FROM NEW YORK/NORTH NEW JERSEY**

Take New Jersey Turnpike South to exit 3. After toll, stay to the right and take Route 168 North. Take to Route 295 South. Take to Route 42 South. Follow Directions above.

### **FROM ATLANTIC CITY**

Take the Atlantic City Expressway to Exit #44 (168 North – Sicklerville/Blackwood) (Camden County College). Go right at the end of the ramp. Go straight through the first traffic light at 168 – Black Horse Pike. Go 1.4 miles and make a left onto County House/Salina Road. Go through one stop sign. At the second traffic light (Route 47/Delase Drive) turn left. The next street on your left is Enterprise Court. (There will be a Hollywood Tans warehouse on the corner). Make a left onto Enterprise Court and proceed to the end of the cul de sac.

*You will see a "Hollywood Tans" sign on the corner of Enterprise Court.*
